

# SeattleLab Software License Agreement

# SLNet 5.0



## License and Usage

This SeattleLab License Agreement ("License") permits customer to use one copy of the licensed **SeattleLab SLNet software product** ("SOFTWARE") on any single computer, provided the SOFTWARE is in use on only one computer at any time.

If customer has multiple licenses for the SOFTWARE, then at any time the customer may have as many copies of the SOFTWARE in use as they have licenses.

The SOFTWARE is "in use" on a computer when it is loaded into the temporary memory (i.e., RAM) or installed on the hard disk or other storage device of that computer, except that a copy installed on a network server for the sole purpose of distribution to other computers is not "in use".

If the anticipated number of users of the SOFTWARE will exceed the number of applicable Licenses, then the customer must have a reasonable mechanism or process in place to assure that the number of persons using the SOFTWARE concurrently does not exceed the number of Licenses.

## Title and Ownership

SeattleLab warrants that it is the sole owner of the SOFTWARE.

No title to or ownership of SeattleLab products, copyrights, patents or trademarks used under the license agreement are transferred to customer. Notwithstanding any provision of the license agreement to the contrary, SeattleLab owns and retains all title and ownership of all intellectual property rights in the SOFTWARE and copyrights, patents or trademarks.

## Transfer

Customer may assign this License to a subsidiary, a successor in interest in case of a merger or acquisition of Customer or in case of a transfer of all or substantially all of its assets, or the assets of a major division, to another party by notification to SeattleLab.

## Restrictions

Customer agrees that it will not duplicate, rent, lease, redistribute or resell purchased products and accompanying license keys/codes. The customer may not reverse-engineer, decompile, or disassemble the SOFTWARE.

## Copyright

The SOFTWARE is protected by United States copyright laws and international treaty provisions. Customer must treat the SOFTWARE like any other copyrighted material and may not copy the SOFTWARE or written materials accompanying the SOFTWARE except for backup or archival purposes.

## Limited Warranty

SeattleLab warrants that (a) the software will perform in accordance with the accompanying written materials for a period of thirty (30) days from the date of receipt.

SeattleLab does not make any other warranties or representations with regard to any Product, whether written or oral. THE WARRANTIES DESCRIBED IN THIS SEATTLELAB SOFTWARE LICENSE AGREEMENT ARE IN LIEU OF ALL OTHER WARRANTIES, EXPRESSED OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NON-INFRINGEMENT.

## Indemnification.

SeattleLab will defend, indemnify, protect and hold harmless customer from and against any and all claims, losses, liens, demands, attorneys' fees, damages, liabilities, costs, expenses, obligations, causes of action, or suits, (collectively "Claims") to the extent that such Claims are caused by, arise out of, or are connected

in any way with claimed infringement of any third party intellectual property right by the SOFTWARE, documentation, or by any other product provided by SeattleLab for use with the SOFTWARE ("Infringement Claims"). Customer will reasonably cooperate in the defense of an Infringement Claim at SeattleLab's sole expense, and may appear, at its own expense, through counsel of its own choice. Customer will not enter into any settlement of any Infringement Claim without the prior written consent of SeattleLab.

## Customer Remedies

SeattleLab's entire liability and customer's exclusive remedy shall be, at SeattleLab's option, either: (a) return of the license fee paid or (b) repair or replacement of the SOFTWARE. This Limited Warranty is void if failure of the SOFTWARE or hardware has resulted from accident, abuse or misapplication. Any replacement software will be warranted for the remainder of the original warranty period or thirty (30) days, whichever is longer.

## Limitation on Liability

IN NO EVENT SHALL SEATTLELAB BE LIABLE FOR ANY LOSS OF PROFITS, LOSS OF BUSINESS, LOSS OF USE OR OF DATA, INTERRUPTION OF BUSINESS, OR FOR INDIRECT, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY KIND, EVEN IF SEATTLELAB HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES, OR FOR ANY CLAIM AGAINST CUSTOMER BY ANY OTHER PERSON OR ENTITY. IN NO CASE WILL SEATTLELAB BE LIABLE FOR ANY REPRESENTATION OR WARRANTY MADE TO ANY THIRD PARTY OF CUSTOMER, ANY AGENT OF CUSTOMER, ANY DISTRIBUTOR, DEALER OR OTHER PERSON OR ENTITY IN THE CUSTOMER PURCHASING CHAIN.

The aggregate liability of SeattleLab with respect to the products purchased shall not exceed the amount paid by the customer to SeattleLab with regard to the product or activity that is the basis for such liability.

## Maintenance Support Plan

SeattleLab provides a 7 day Maintenance Support Plan for the SOFTWARE at no charge from the date of installation. Maintenance support includes telephone and email assistance, corrections, fixes, and improvements to the SOFTWARE. Subsequent periods are available at an extra cost to the customer. The Maintenance Support Plan does not include installation assistance or upgrades to new version releases of the SOFTWARE.

## U.S. Government Restricted Rights

Customer acknowledges that the laws and regulations of the United States restrict the export and re-export of software, commodities and technical data of United States origin. Accordingly, without limitation of the foregoing, customer shall do all things necessary to comply with the U.S. Export Administration and other applicable export laws and regulations as they apply to the products purchased by the customer.

Customer will comply with all applicable laws, regulations, rules, orders and other requirements, now or hereafter in effect, of any applicable governmental authority, in its use of the SOFTWARE.

The SOFTWARE and documentation are provided with restricted rights. Use, duplication, or disclosure by the Government is subject to restrictions as set forth in subparagraph (c)(1)(ii) of the Rights in Technical Data and Computer Software clause at DFARS 252.227-7013 or subparagraphs(c)(1) and (2) of the Commercial Computer Software-Restricted Rights at 48 CFR 52.227-19, as applicable.

## Governing Law

This Agreement shall be governed by the laws of the State of California, United States of America.
